Everyone is permitted to copy and distribute verbatim copies of this license document, but changing it is not allowed.

Preamble

The purpose of this Flopoco license is to grant users the right to modify and redistribute the software governed by this license within the framework of an open source distribution model.

The exercising of this right is conditional upon certain obligations for users so as to preserve this status for all subsequent redistributions.

This license is based on the version 3 of the GNU Affero General Public License (GNU AGPL), but includes specific provisions due to the nature of the Program. As a main deviation, users agree to convey any Generated Code obtained through its use of the Program under version 3 of the GNU Lesser General Public License (GNU LGPL). In case this license is incompatible with users' intended use of the Program, users may contact its authors in order to negotiate a separate proprietary license, under a dual licensing scheme.

In consideration of access to the source code and the rights to copy, modify and redistribute granted by the license, users are provided only with a limited warranty and the software's author, the holder of the economic rights, and the successive licensors only have limited liability.

In this respect, the risks associated with loading, using, modifying and/or developing or reproducing the software by the user are brought to the user's attention, given its free software status, which may make it complicated to use, with the result that its use is reserved for developers and experienced professionals having in-depth computer knowledge. Users are therefore encouraged to load and test the suitability of the software as regards their requirements in conditions enabling the security of their systems and/or data to be ensured and, more generally, to use and operate it in the same conditions of security. This license may be freely reproduced and published, provided it is not altered, and that no provisions are either added or removed herefrom.

TERMS AND CONDITIONS

0. Definitions.

"The Program" refers to the Flopoco software licensed under this License. Each licensee is addressed as "you". "Licensees" and "recipients" may be individuals or organizations.

To "modify" a work means to copy from or adapt all or part of the work in a fashion requiring copyright permission, other than the making of an exact copy. The resulting work is called a "modified version" of the earlier work or a work "based on" the earlier work.

A "covered work" means either the unmodified Program or a work based on the Program, to the exclusion of the Generated Code.

To "propagate" a work means to do anything with it that, without permission, would make you directly or secondarily liable for infringement under applicable copyright law, except executing it on a computer or modifying a private copy. Propagation includes copying, distribution (with or without modification), making available to the public, and in some countries other activities as well

To "convey" a work means any kind of propagation that enables other parties to make or receive copies. Mere interaction with a user through a computer network, with no transfer of a copy, is not conveying.

1. Source Code.
